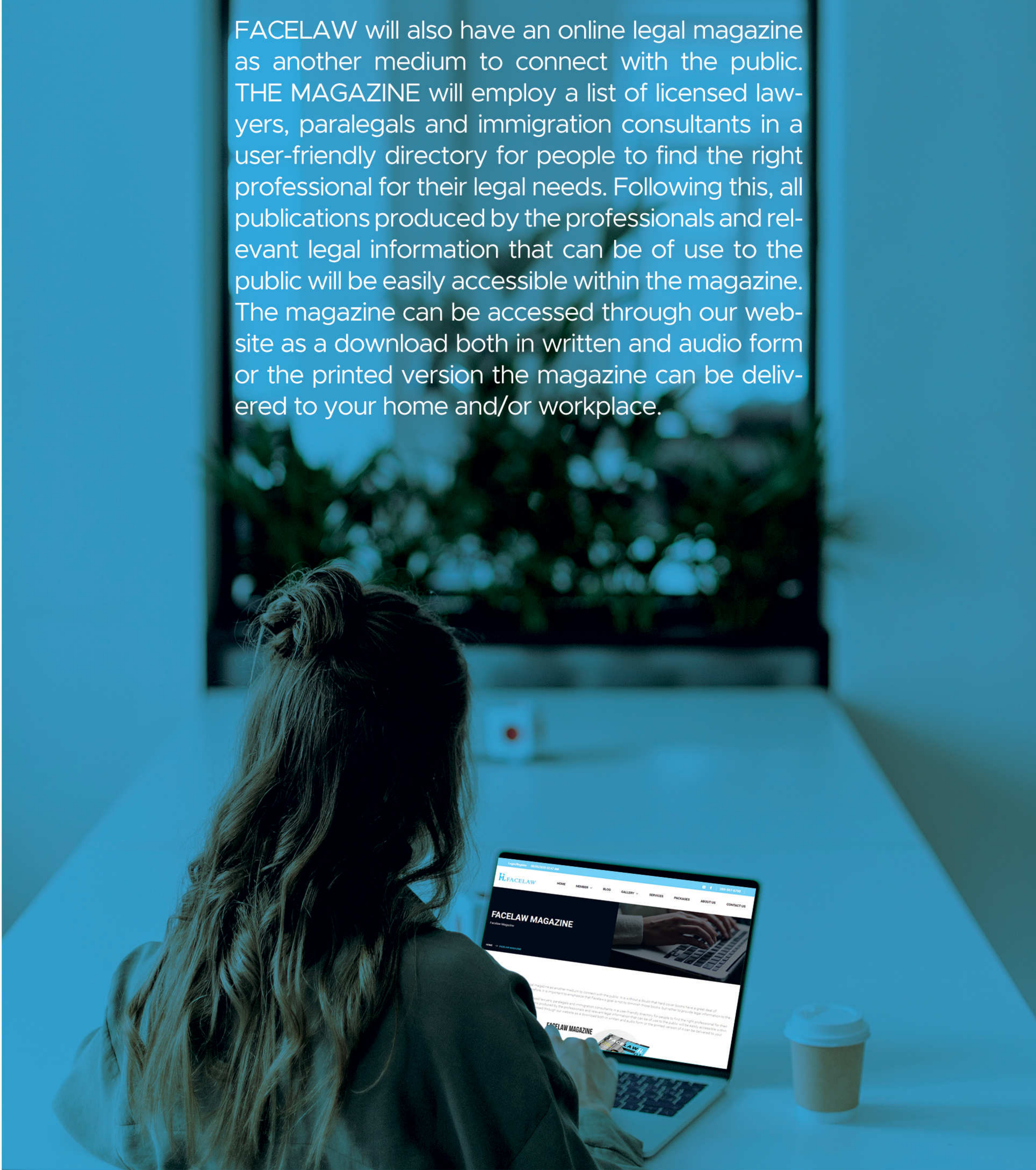

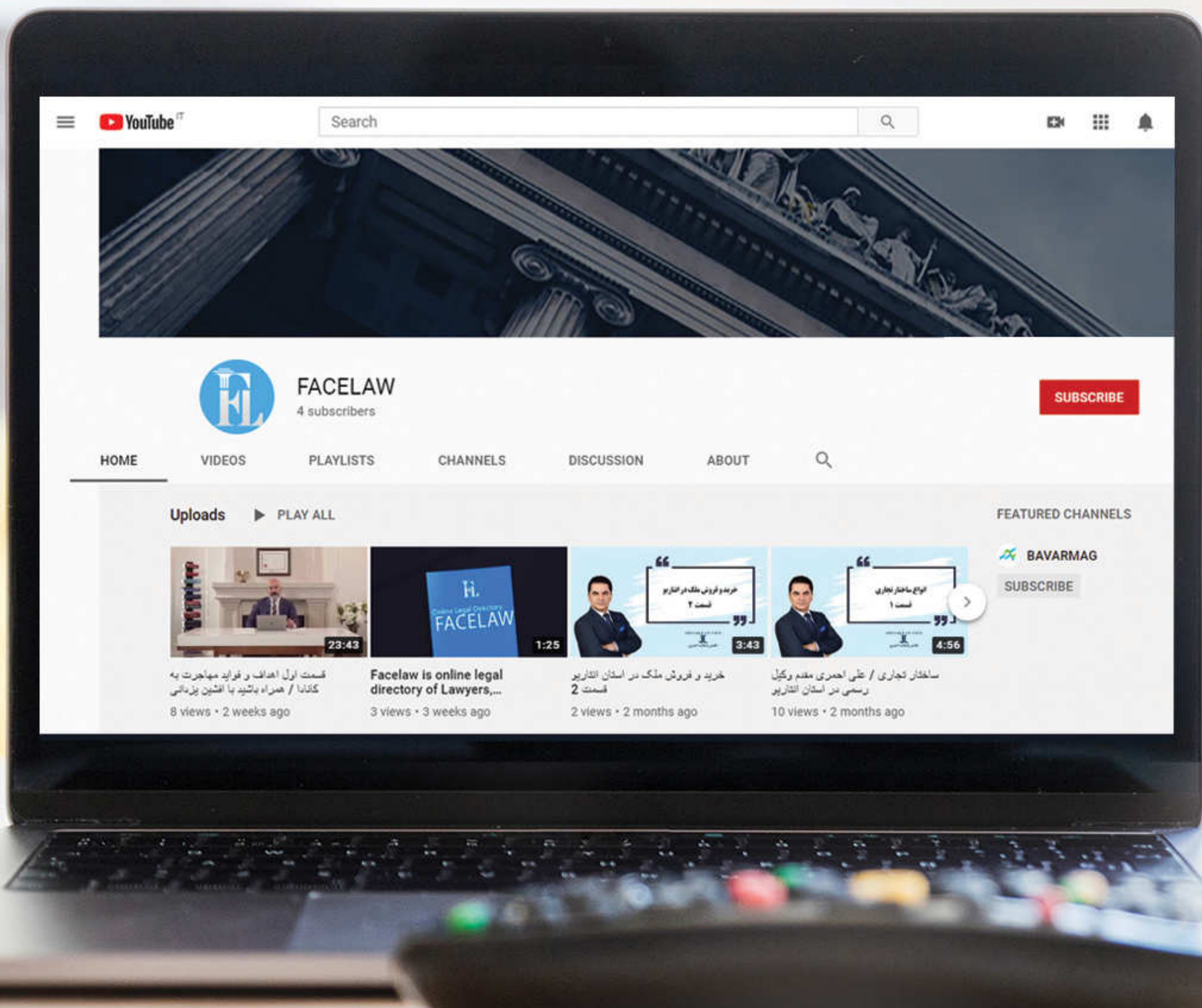
In order for parties to agree to the terms of any agreement, they need to be confident that: a) a contract between them exists; and b) the contract and its terms are enforceable.

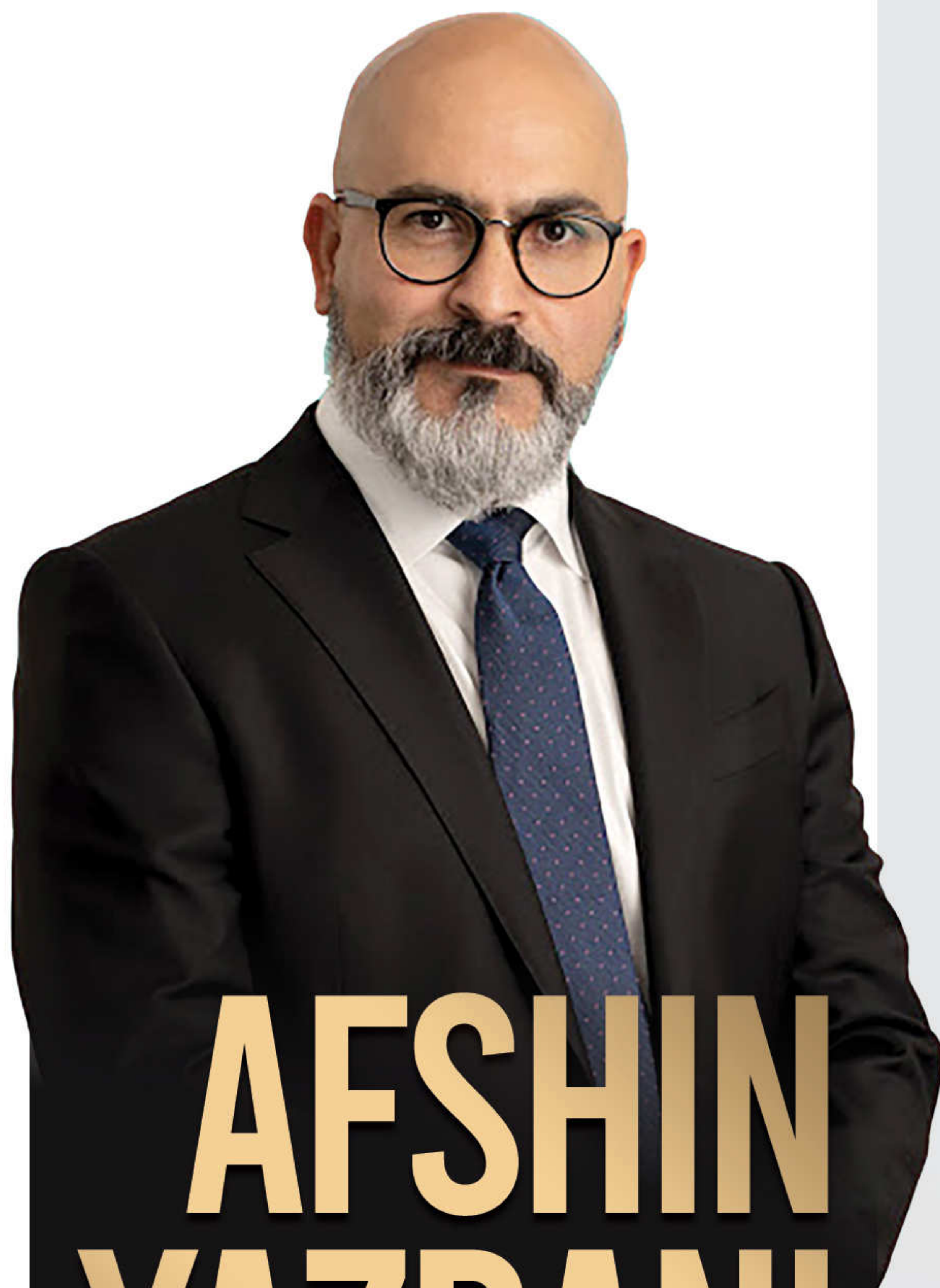

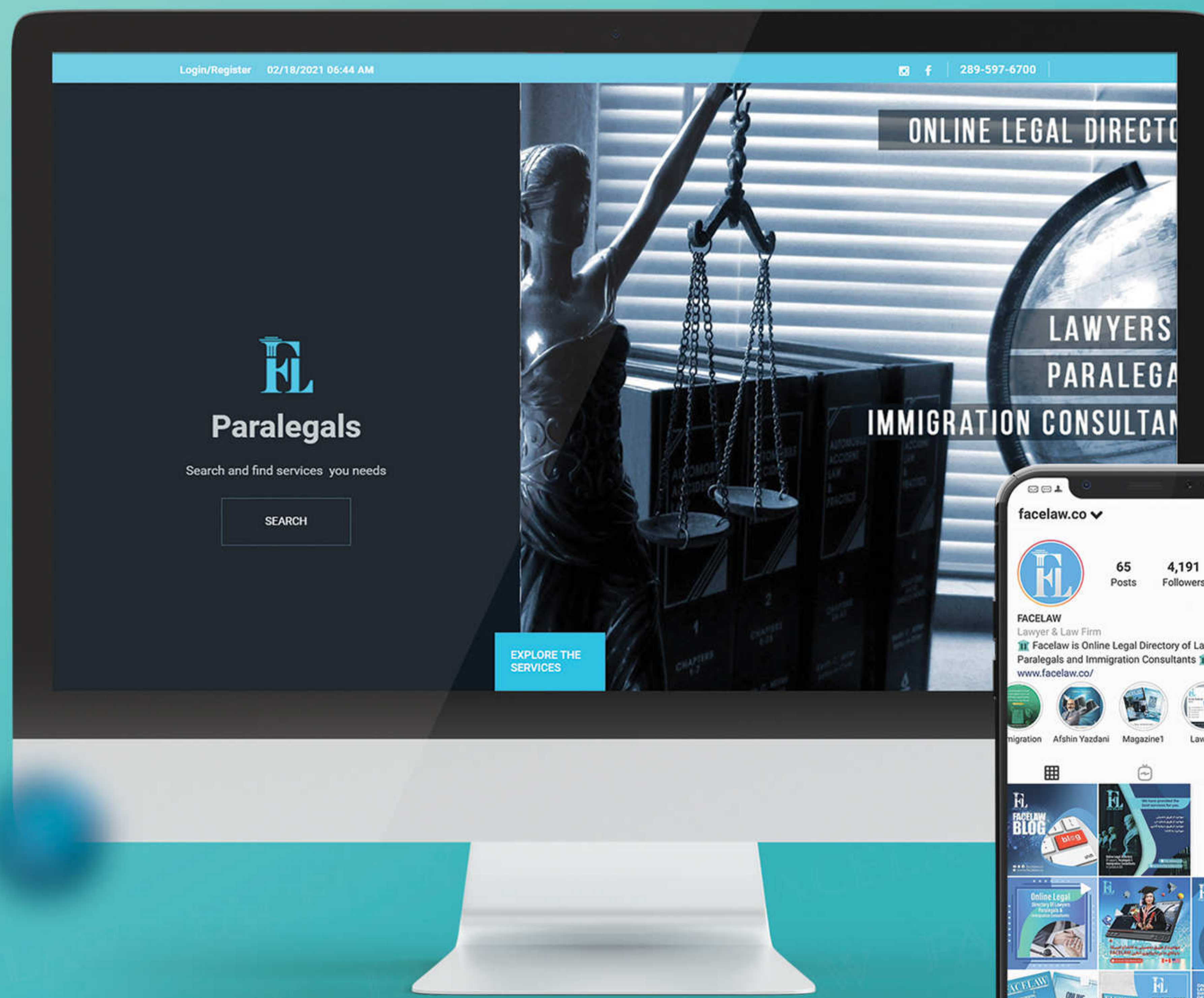
