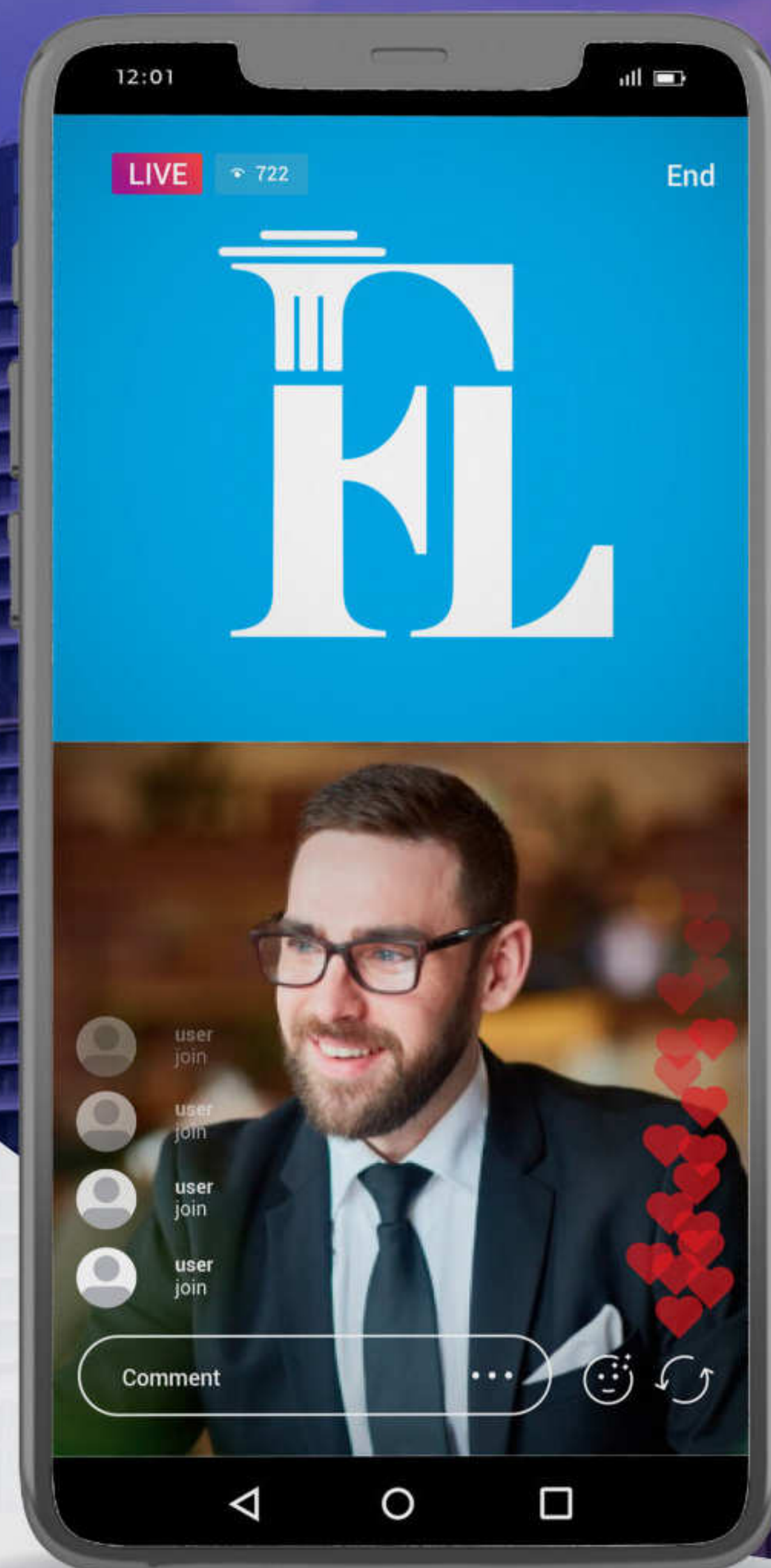

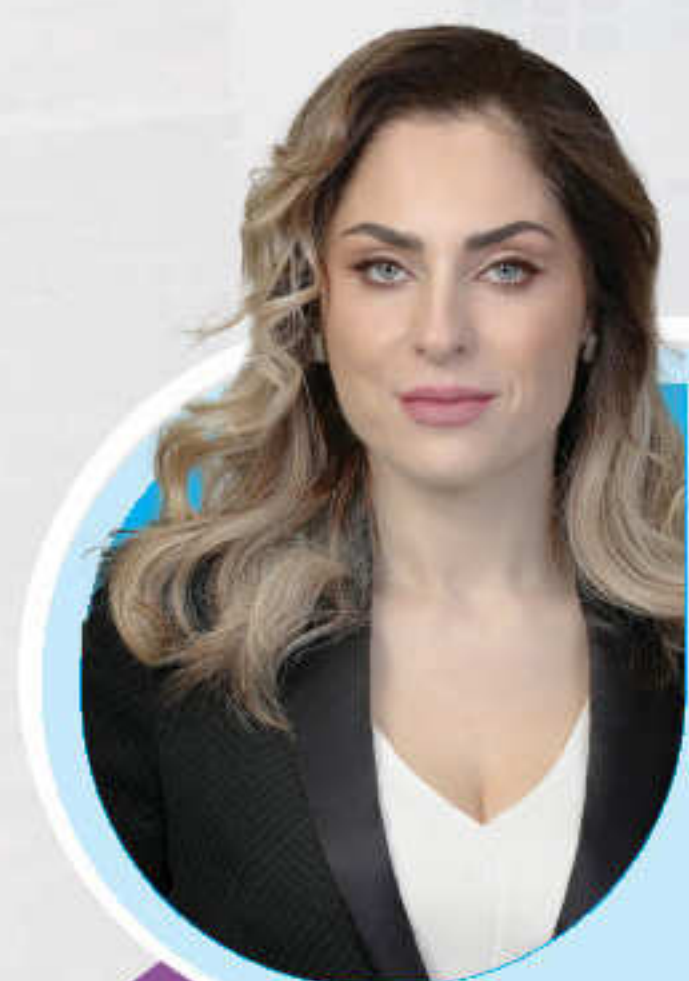

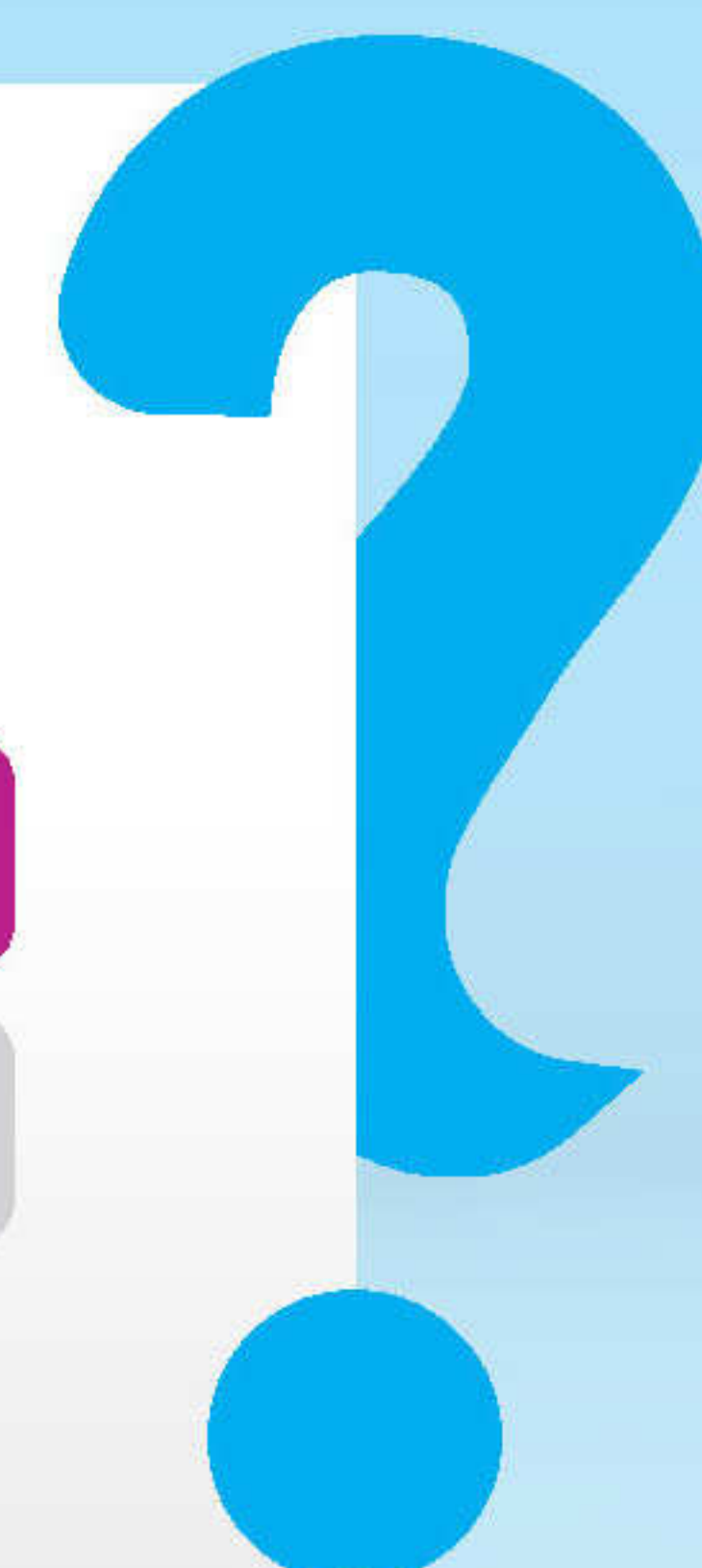

COMMON LEGAL QUESTIONS ANSWERED ABOUT: **SPOUSAL SUPPORT**

My spouse cheated. Do I need to pay spousal support?

Yes as family law operates on a "no-fault" basis. The conduct of a spouse, including adultery, is not relevant to the determination of entitlement to or the amount of spousal support. Spousal support is based on factors such as financial need, compensatory claims, and contractual arrangements, not marital misconduct.

My spouse cheated. Do I need to divide my assets?

Yes. The division of assets in Ontario is governed by a "no-fault" regime. The reasons for the breakdown of the marriage, including adultery, do not affect the equalization of net family property. Each spouse is entitled to an equal share of the increase in value of family property acquired during the marriage, subject to statutory exclusions and exceptions, regardless of marital misconduct.

Am I liable for my spouse's date of marriage debt during our divorce?

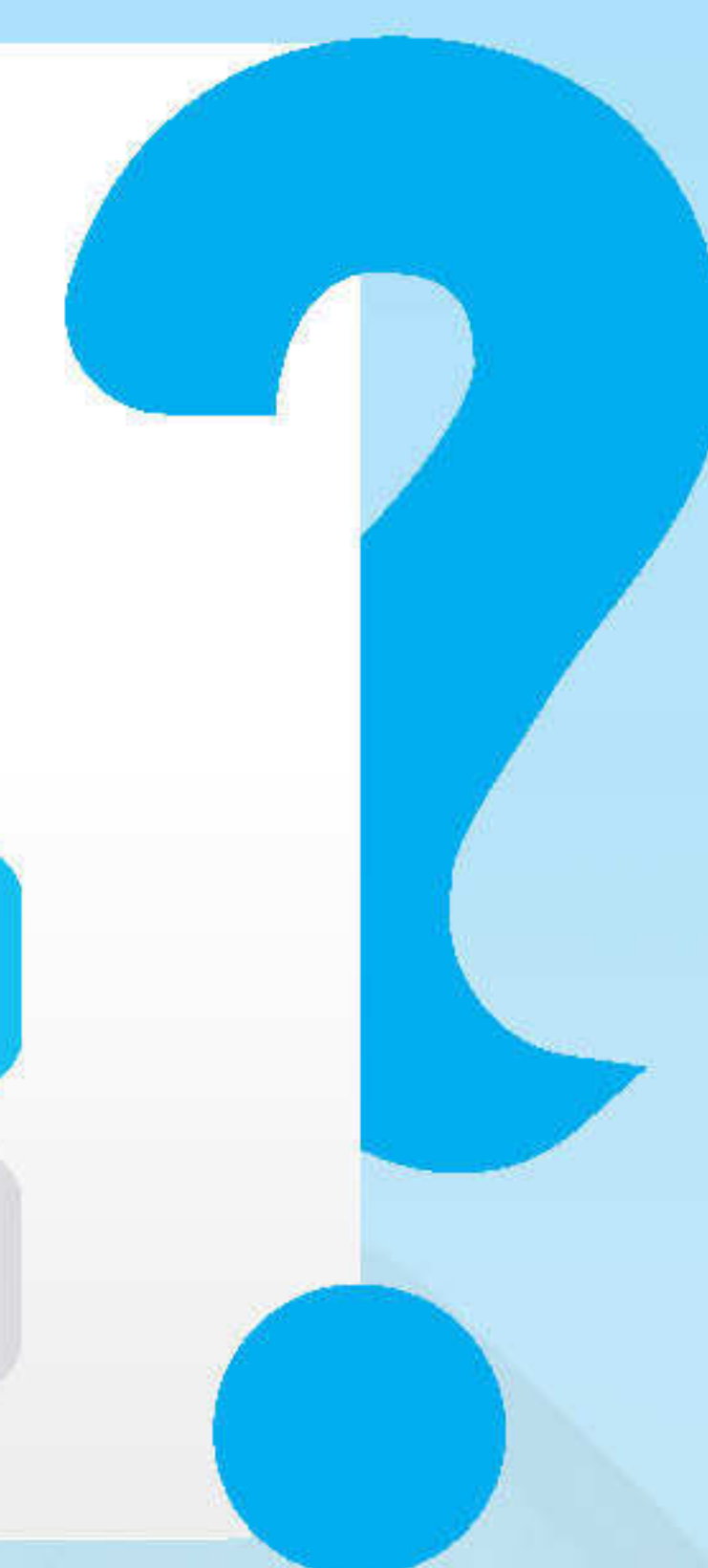
No. In the equalization of net family property, each spouse's net worth at the date of marriage is deducted from their net worth at the date of separation. Debts existing at the date of marriage are subtracted from the calculation of net family property for the spouse who incurred them. You are not personally liable for your spouse's pre-marriage debts; however, those debts may reduce your spouse's net family property and thus affect the equalization payment.

COMMON LEGAL QUESTIONS ANSWERED ABOUT: **Family Divorce**

Is a lawyer mandatory to file for divorce in Ontario?

No, but it is strongly recommended. Divorce law is complex, and a lawyer ensures your rights regarding property, custody, and support are fully protected.

Can I get a divorce in Ontario even if my spouse doesn't agree?

Yes. Under Canadian law, after one year of separation, or in cases of abuse or adultery, you can file for divorce without the other party's consent.

How is property divided in a divorce in Ontario?

According to Ontario's Family Law Act, all marital assets are typically divided equally unless you sign a legal agreement (e.g. prenup or separation agreement).

Safe and Serene Backyards:

Swimming Pool Safety

A swimming pool comes with risk. Between April 1, 2011 and April 13, 2023, there were 1,109 drowning related cases according to the Canadian Hospitals Injury Reporting and Prevention Program. Of those, 624 deaths occurred in residential or public pools. Backyard pools are also the leading cause of drowning for children five and younger according to the Canadian National Lifesaving Society.

Drowning is not the only swimming pool accident risk. Slips and falls are also common and people can suffer broken bones and catastrophic injuries after diving into too shallow water. The chemicals required to keep your pool's water clean and clear can also cause burns or irritate skin and eyes.

Check With Your Municipality About Pool Bylaws

Each municipality has its own regulations regarding pools, so it is important to ensure you comply with your city's bylaws. By Laws for both Toronto and Ottawa define a swimming pool as anything on private property that can be used for swimming, wading, or bathing with a depth that exceeds 60 cm (2 feet) at any point. If you have a swimming pool, whether inground, above ground or even temporary (hot tubs count too!), you must have an enclosure that surrounds the area around that pool. There can be no openings, except for a gate, which must have a lock. Municipalities also have standards for fences that dictate height, material and structure as well as regulations dealing with placement requirements.





You Have a Duty of Care

Under Ontario's Occupiers' Liability Act the occupier of a premises are responsible for ensuring all visitors are reasonably safe when visiting your home.

That duty of care extends to your swimming pool. You can be held liable if you fail to ensure there are sufficient safety measures in place. For example, the area surrounding a pool can be slippery, posing an increased risk for slip and falls. Consider a non-slip surface or signage warning of potential hazards. Verbal warnings to guests are also advisable. Many people enjoy diving into a pool but the risk of head, neck and spinal cord injury makes it extremely dangerous, according to the Canadian Red Cross. They also report that more than 40 per cent of spinal injuries caused by careless diving happen in backyard pools, and 95 per cent of diving injuries occur in water 1.5 metres deep where there are no warning signs or supervision in place.

Don't Let a Pool Accident Spoil Your Fun

Homeowners should check their insurance coverage to ensure they are adequately covered in the event of an accident at their pool. **Many accidents can be prevented by taking common safety measures:**

- Take certified swimming lessons.
- Non swimmers should wear lifejackets or personal floatation devices and be supervised by someone with good swimming skills.

- Establish pool rules, which can include swimming with a buddy and ensuring children are accompanied by an adult.
- Review your pool rules with guests.
- Enter the water feet first instead of diving.
- Don't swim if you have been using drugs or alcohol.
- Clear the area surrounding the pool of any toys, debris or tripping hazards.
- Have throwing or reaching assists readily accessible to help those struggling in the water.
- Post shallow water and no diving signs.
- Have an emergency plan and a first aid kit.
- Learn first aid.

Civil Action for Human Sex Trafficking Cases

Sometimes, the perpetrator who commits sexual assault or abuse is not acting alone. Rather, one or more other people or institutions have, either intentionally or negligently, facilitated conditions that create opportunities for these crimes to occur or continue. In some cases, these people and / or institutions have participated in or contributed to a form of sexual exploitation called human trafficking. Public Safety Canada “notes that human trafficking” is often described as a modern day form of slavery.

Who Is at Risk of Being Trafficked and Who Are the Traffickers?

Statistics Canada reports that 94 per cent of victims of trafficking identify as female, and Indigenous and racialized women and girls are disproportionately at risk of being trafficked.

Conversely, more than four in five persons accused of human trafficking identify as male. Men aged 18 to 34 accounted for almost two thirds of all persons accused of human trafficking in Canada between 2012 - 2022. Consistent with research that indicates some of the girls that fall victim to traffickers are recruited to traffic other girls, among the 109 youth accused of human trafficking between 2012-2022, 55% of the accused were girls and 44% of the accused were boys. While this crime can be committed anywhere, calls to the Canadian Human Trafficking Hotline have overwhelmingly come from larger urban centres (with populations over 100,000) and from Ontario (two thirds of all calls).

Recent Action to Protect People Vulnerable to Trafficking

Canadian governments have taken steps to help survivors of human trafficking and to reduce the prevalence of this crime.

In addition to partially funding a national hotline (1-833-900-1010) that helps connect victims of this crime with resources such as housing, counselling,

and emergency financial support, the federal government has created a comprehensive National Strategy to Combat Human Trafficking.

Human trafficking is a criminal offence in Canada. Ontario has also enacted statutes to combat aspects of trafficking and provide remedies for victims.

For example, if someone has reasonable grounds to believe a child is in need of protection due to suffering or being at risk of suffering physical abuse, sexual abuse, emotional abuse, or neglect, they have a duty to under the Child Youth and Family Services Act to report their suspicion to the Children's Aid Society.

The Path to Seek Justice

There are many reasons why a victim may wait to pursue justice in the courts. Experiencing sexual violence can cause lasting trauma that may contribute to significant mental health challenges and increase the risk of addiction or self-harm. To avoid debilitating symptoms of post-traumatic stress disorder, a victim may consciously avoid anything that could be a trigger. Survivors may also be financially insecure, fear retaliation or being disbelieved, or worry about their own immigration status or other legal issues.

If and when they do choose to come forward, victims of human trafficking have a variety of legal avenues they can potentially pursue, and it's very important to remember that these options are not time-limited by statute. Therefore, if you or a loved one have been a victim of sexual trafficking, you do not have to file a police report or make a civil claim within a certain period to protect your right to pursue criminal charges or seek damages in a lawsuit. Individual factors in a case should be carefully considered before choosing how to proceed, but in general, civil cases are more likely to have a positive outcome. Rather than having to prove guilt beyond a reasonable doubt, in a civil lawsuit against a defendant, the plaintiff must only prove they were harmed on the balance of probabilities.
