01



Having a Will ensures that your assets and possessions will be distributed in the manner that you wish. Therefore, if you do not have a Will, the law, Estates Administration Act and Succession Law Reform Act (SLRA) sets out a distribution scheme that may not be what you desire.

02



Having a Will ensures that a person you trust will fill the role of the guardian to look after your minor children. Therefore, if you do not have a Will, the guardian will be appointed by the Court itself, which may indeed not be your desired choice.

03



Having a Will ensures that a person you trust and is familiar with your affairs will handle your estate. Whereas, if you do not have a Will, an executor will be appointed by the Court, which again may indeed not be your desired choice..

04



Having a will may result in reducing final costs.

05



Having a will may result in reducing legal costs and delays in handling your estate.

06



When an individual passes without a Will and without successor(s), his or her estate is potentially vested in the Government. Having a Will ensures your choices are given priority. If you wish to have a solicitor review your estate and help you make a Will, please contact us.

COMMON LEGAL QUESTIONS ANSWERED ABOUT: **Parenting Decision-Making**

Did you know that one parent can have parenting decision making authority while the child resides with the other parent?

Yes. Under the Children's Law Reform Act and Divorce Act, decision making responsibility (formerly "custody") and parenting time (formerly "access") are distinct. One parent may have sole decision making authority while the child primarily resides with the other parent.

What if it is not safe for my child to see the other parent?

If there are safety concerns (e.g., abuse, neglect), you may seek a court order for supervised parenting time or to suspend parenting time. The court's paramount consideration is the child's best interests, including safety and well being.

Can I travel with my child without the other parent's consent?

You require the other parent's written consent or a court order to travel internationally with your child. Unilateral travel without consent may be considered a breach of agreement or abduction.

Reading insurance contracts is not an easy task; they are usually lengthy documents with complicated clauses and legal terms. However, it would be dangerous to ignore the details; in order to ensure the coverage you are paying for would meet your needs in case of an accident, it is important to review your policy documents with your broker line by line.

Why You Should Read Your Coverage Documents

When individuals skim or sign their insurance policy documents without reading them first, they often miss the following crucial details:

- Exclusions and limits hidden in fine print; for instance, rehabilitation coverage may seem generous at first glance. However, most may be concerned that it is stopped after only one year, regardless of the insured's recovery status.
- Common misconceptions about benefits; for example, many believe that caregiver benefits or income replacement are automatically included in every insurance policy. In reality, the **"standard package"** often includes significantly less benefits than individuals often assume.

- Coverage limits that do not match practical costs; for instance, a \$25,000 medical benefit may seem sufficient at first. In reality, it can run out in just a few months if the insured individual is seriously injured.

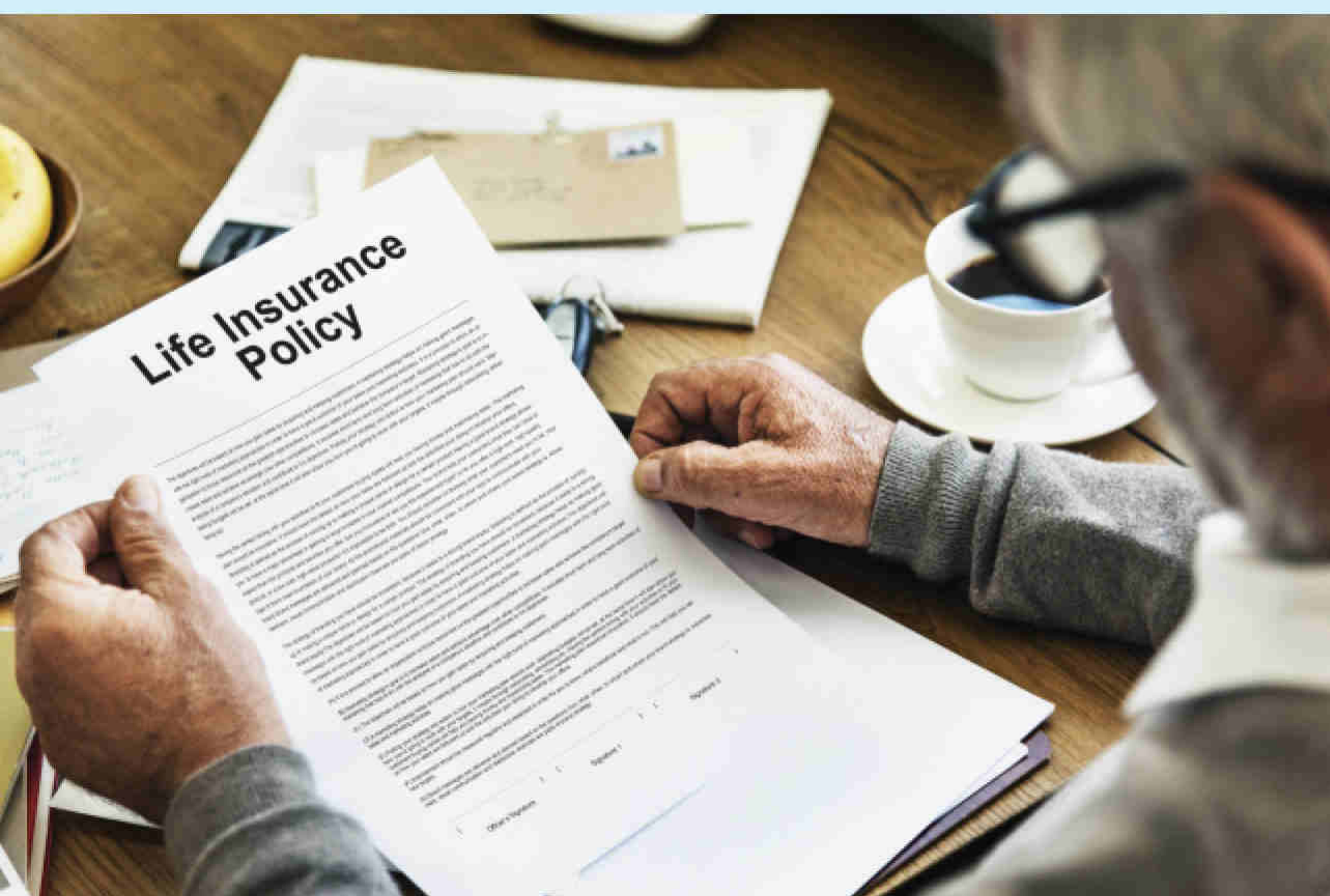
Reviewing your documents in detail will prompt you to seriously consider how your insurance coverage can affect your life in the event of an unforeseen accident.

How to Discuss Optional Benefits with Your Broker

Basic insurance policies are limited, which is why optional benefits are usually available. All too frequently, individuals tend to ignore these benefits in order to save an additional \$10 or \$20 a month on their premium. However, the equation quickly takes a shift when weighing risk over protection.

Do not just ask your broker, **"What is included?"**. Instead, consider the following points:

- **How much would I be compensated under this policy if I missed six months of work?**
- **How does the optional upgrade differ from the standard accident benefits?**
- Would I receive coverage if my spouse needed to take time off work to care for me?
- What are the costs of including these options versus excluding them?



It is important to frame discussions around "potential financial losses" rather than "extra costs." A few extra dollars a month can save thousands of dollars in the future.

The Significant Shift Occurring in July 2026: Income Replacement Benefits (IRB)

Income Replacement Benefits (IRB) are currently automatically included in the majority of Ontario's auto insurance policies. These benefits are intended to partially replace your income in the event that an automobile accident renders you unable to work.

IRB will no longer be standard as of July 2026 and will be considered optional; this implies that individuals will not receive IRB coverage unless they specifically purchase and include it in their policy.

This change is highly significant since IRB is one of the most important components of accident benefits. Medical bills may mount up, but losing paycheques can devastate a household even more quickly. An individual may be forced to rely solely on family support, short term employer disability plans (if available), or personal savings in the absence of IRB.

Many insured individuals may mistakenly assume that they are still covered with IRB. However, due to the recent changes, IRB will

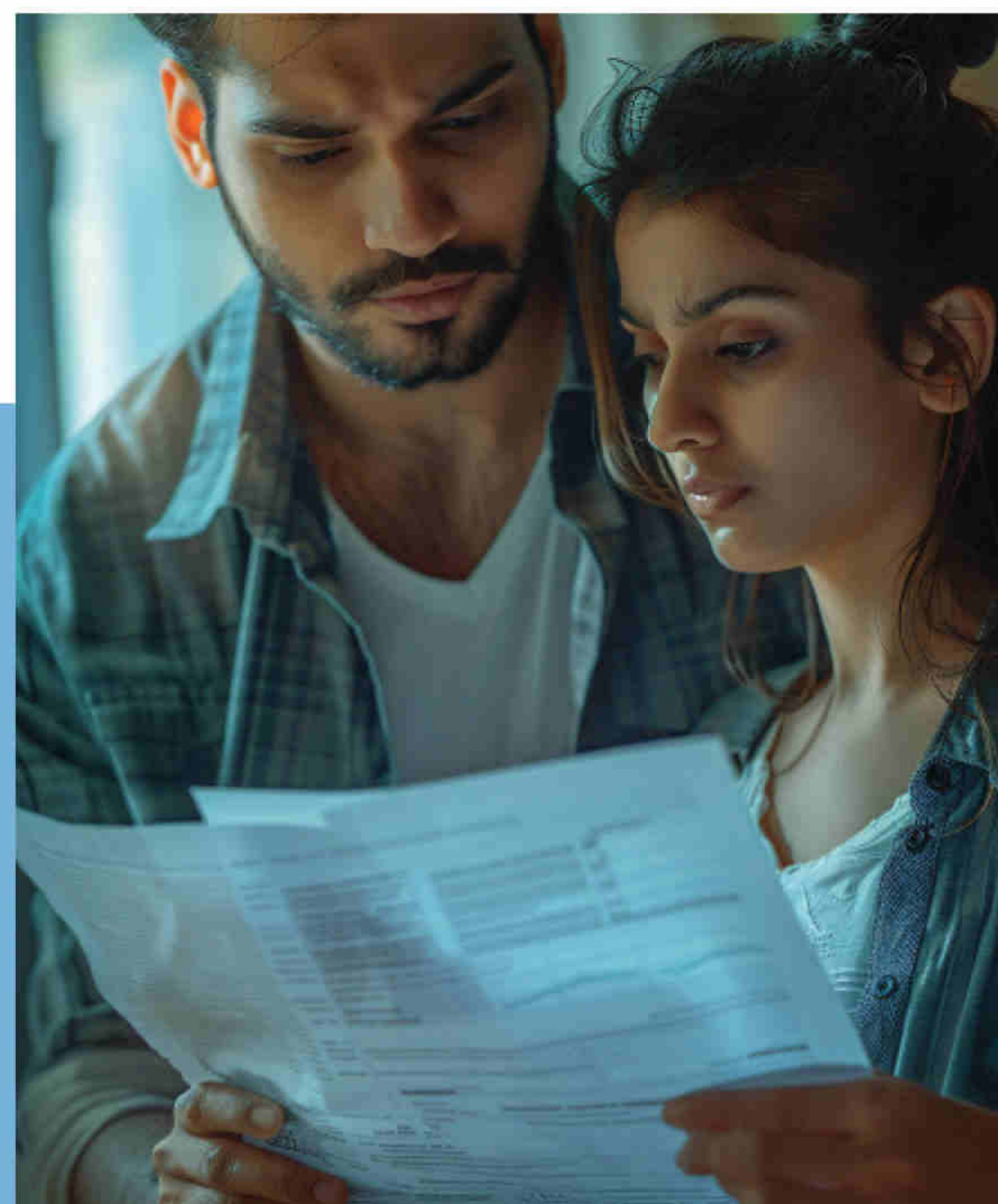
no longer be included in standard policies after July 2026 unless explicitly requested and purchased.

Reasons to Consider Purchasing IRB

Consider this; how would your family manage if you made \$60,000 a year and were hurt in an accident that prevented you from working for a year? Utility bills, groceries, rent or mortgage payments, and auto payments will all continue, regardless of whether or not you are receiving payment from work.

Your insurer may compensate you for some of your medical and rehabilitation costs without IRB. However, this will not make up for the money you have lost while off work. IRB will help you support yourself while you stay home and heal.

For independent contractors, self employed individuals, or anyone without a strong employer benefits plan, IRB is a necessity rather than a luxury.





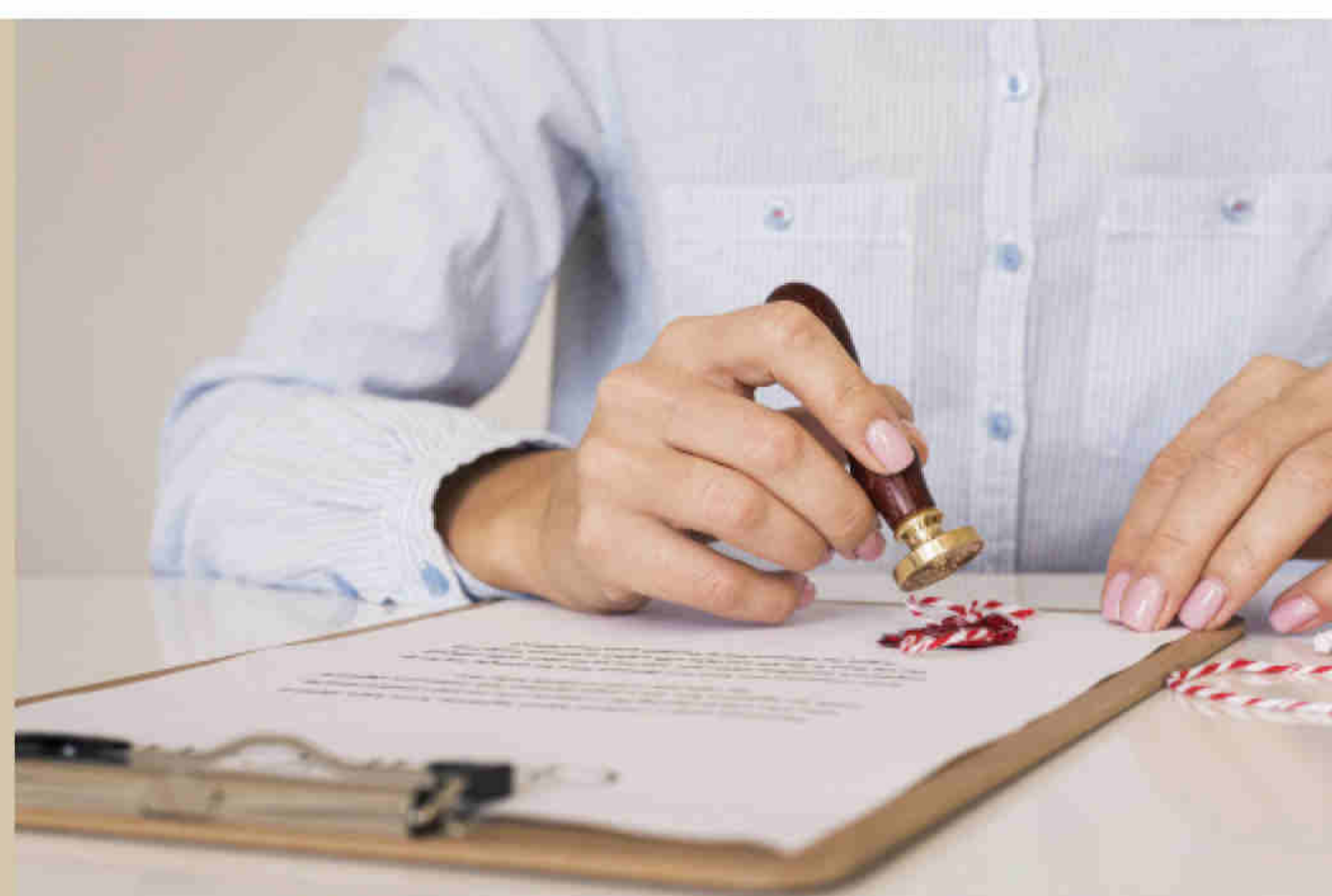

The role of Applicant's Affidavit in an Application for Judicial review:

Subrule 12(1) of the Federal Courts Citizenship, Immigration and Refugee Protection Rules provides that an affidavit **“shall be confined to such evidence as the deponent could give if testifying as a witness before the Court”**.



Thus, hearsay is not permitted. Subrule 12(2) provides that no cross examination is permitted on an affidavit filed in support of an application for leave unless a judge of the Federal Court allows it for special reasons. In most cases, cross examination would not be necessary. However, if an affidavit filed contains facts that are in dispute, or if there are other special reasons to seek to cross examine on an affidavit filed, counsel can apply for leave pursuant to r. 369 of the Federal Courts Rules.

Failure of the Applicant to File His or Her Own Affidavit:

In some cases, the applicant will not file his or her own affidavit. The Federal Courts Citizenship, Immigration and Refugee Protection Rules, although they do require an affidavit in support of the application for leave and judicial review, do not specify that the affidavit must be from the applicant.

There had been some jurisprudence which appeared to suggest that the failure to file an affidavit from the applicant was fatal to the application for judicial review. Given that there is, however, no express requirement that the applicant file an affidavit, there is no basis to conclude that the failure of the applicant to file an affidavit will automatically be fatal to the application for leave. However, given that the facts in the affidavit must be facts that are within the knowledge of the affiant, it is essential that the affiant possess sufficient knowledge of the facts to be able to file an affidavit that is not based on information and belief.

In Sarmis v. Canada (Minister of Citizenship & Immigration), the court dismissed a preliminary objection that the applicant had not filed an affidavit in the following terms:

I will first deal with a preliminary objection raised by the respondent. The respondent submits that as the applicants have failed to file their own affidavits based on personal knowledge in support of their application for leave, and have just filed the affidavit of Rizni Faruk, paralegal, the lack of a personal affidavit in support of their application for leave is a fatal flaw and a third party affidavit cannot serve to remedy this failure (*Jia Cheng Ye v. Canada (Minister of Citizenship and Immigration)*, (January 12, 2000) IMM-4877-99 (F.C.T.D.)).

In addressing this issue, I refer to the decision of Turcinovica v. Canada (Minister of Citizenship and Immigration), 2002 FCT 104, [2002] F.C.J. No. 216 (F.C.T.D.) (QL), where Dawson J. stated at paragraphs 11, 12 and 13:

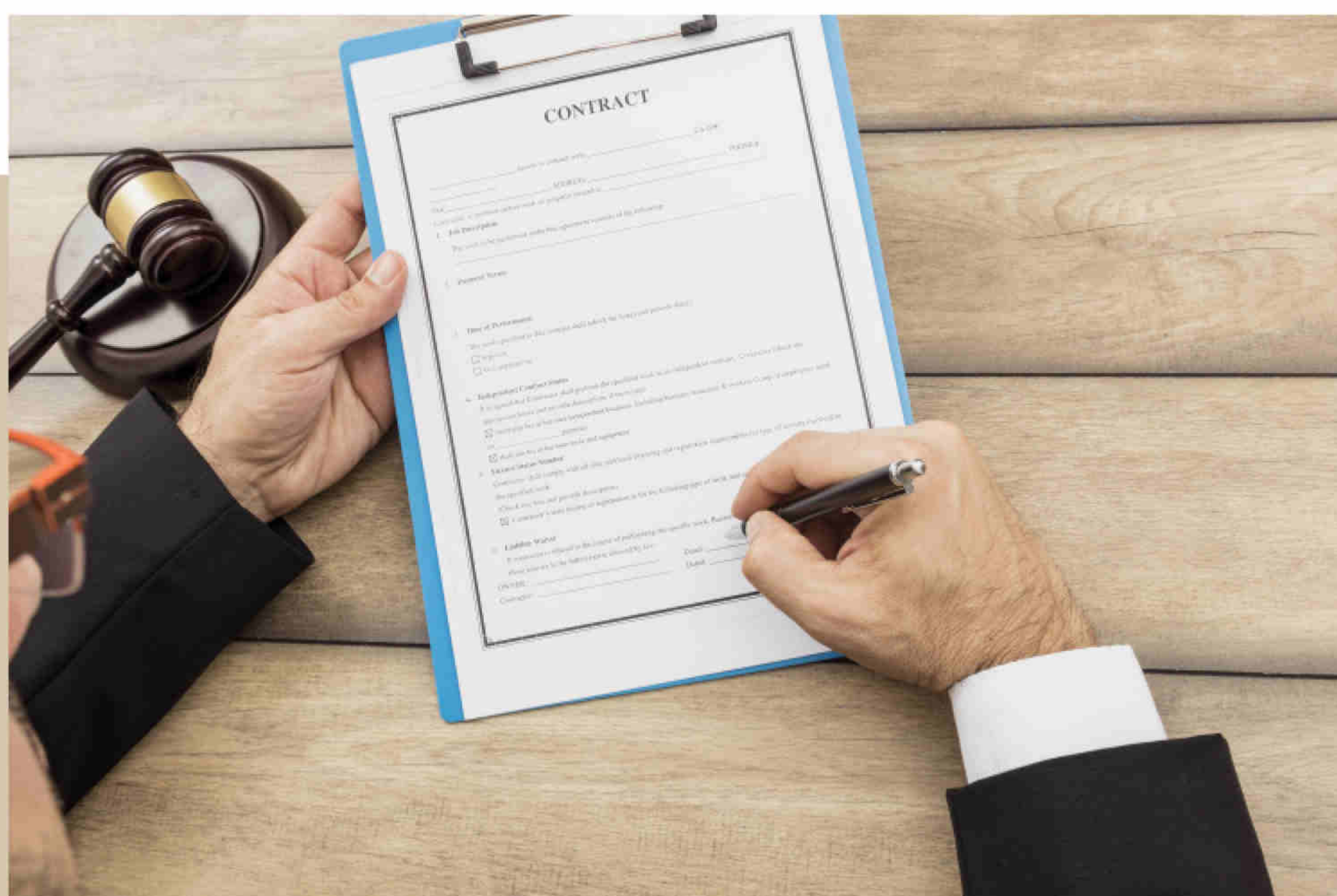
At the commencement of oral argument counsel for the Minister submitted that the application for judicial review should be dismissed because it was not supported by a proper affidavit. Ms. Turcinovica had filed no affidavit and the application was supported by the affidavit of Ms. Turcinovica's lawyer's assistant. This was said to fall short of the obligation on an applicant to produce an affidavit based on personal knowledge. In consequence, it was urged on the Minister's behalf that the application should be dismissed because it was not supported by a proper affidavit.

The failure of an application to be supported by affidavits based on personal knowledge has been held not to result automatically in dismissal of an application for judicial review.

In the present case, I am satisfied that the affidavit before the court is sufficient to establish the fact of the application and its rejection. I am not, therefore, prepared to dismiss the application on this basis.

It is well established that the use of third party affidavits is not fatal to an application for judicial review. Though I do not applaud the use of Third person affidavit, I am not prepared to dismiss the application for judicial review on this basis.

Accordingly, while an applicant's affidavit provides the factual basis for a judicial review, its absence is not automatically fatal. Courts have held that third party affidavits may suffice if they establish the necessary facts, and cross-examination is only allowed in special circumstances.

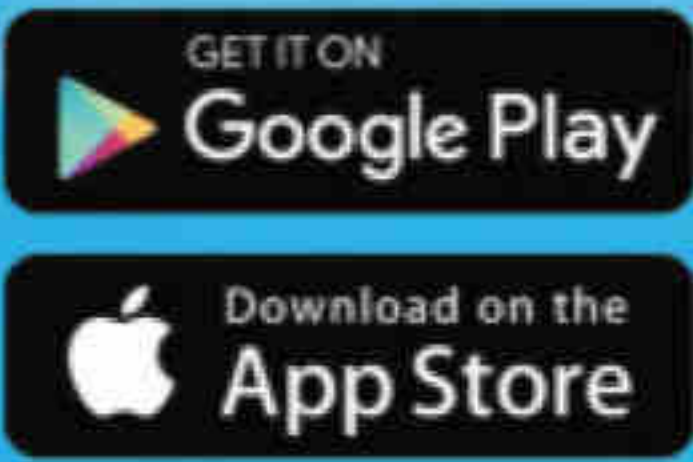

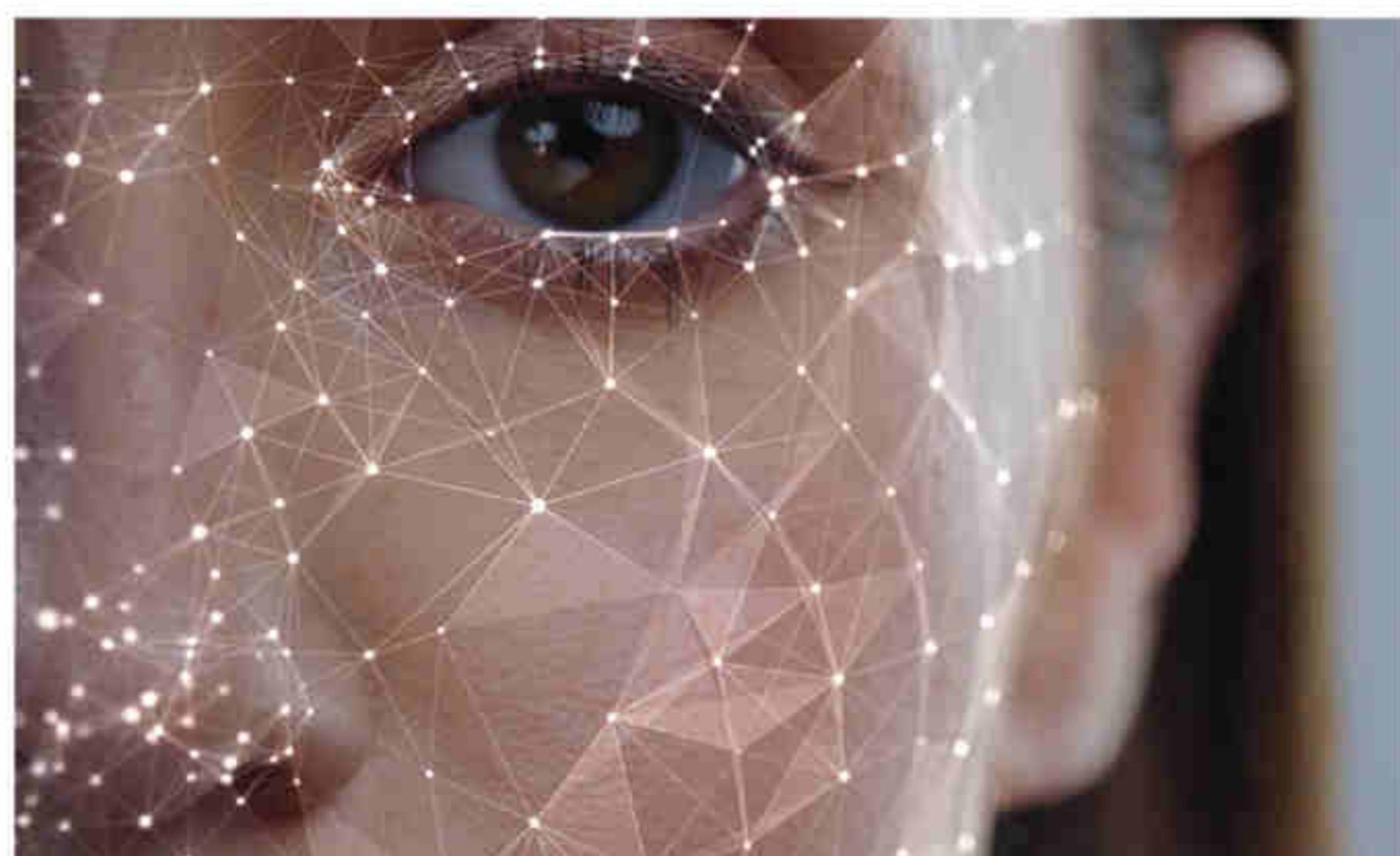
