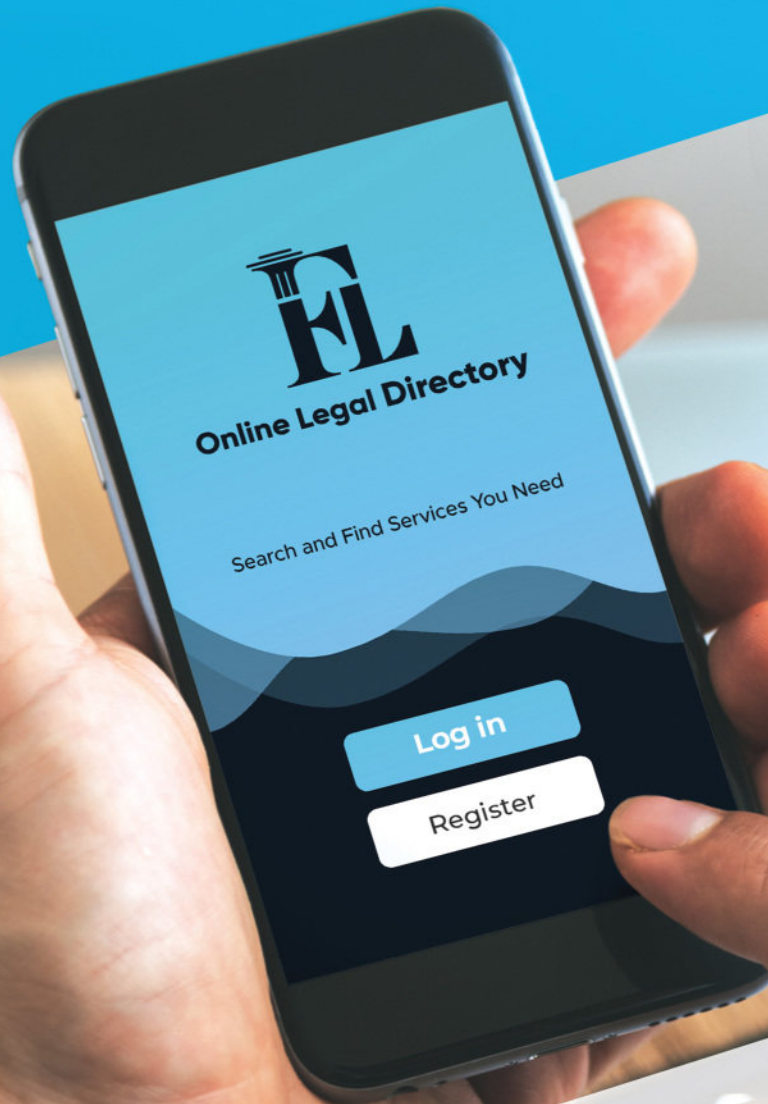

COMMON LEGAL QUESTIONS ANSWERED ABOUT: **Property Division and Equalization**

1. How can I avoid sharing half of my assets during my divorce?

the Family Law Act presumes equalization of net family property. You may exclude certain property, rely on a marriage contract, or argue for unequal division of assets.

2. Why do I have to divide my assets during divorce?

The Family Law Act requires equalization of net family property to ensure fairness between spouses, reflecting the partnership nature of marriage.

3. Do I have to include my debts in my Net Family Property Statement?

Yes. All debts existing on the valuation date (date of separation) must be included in your Net Family Property Statement.

4. Do I have to include my gold in my Net Family Property Statement?

Yes. All assets owned on the valuation date, including gold, must be disclosed and included.

5. Do I have to include my house in my Net Family Property Statement?

Yes. The matrimonial home is included in the calculation, and its value is not subject to the usual exclusion for pre marriage property.

Ontario Land Transfer Tax

The Land Transfer Tax (LTT) in Ontario is a tax paid on every conveyance of land tendered for registration as well as every unregistered disposition of a beneficial interest in land, unless specifically exempt under the applicable legislation. The amount of the LTT payable depends on the value of the consideration as defined in subsection 1(1) of the Land Transfer Tax Act (Ontario). The definition of the value of consideration is broader than simply the purchase price set out in an agreement of purchase and sale and can include, but is not limited to, items such as any liabilities assumed, any benefits conferred, and the cost of upgrades or extras. LTT is a marginal tax rate and each portion of the value of consideration is taxed at a unique rate based on the total value of consideration.



“ The LTT is structured as follows:

For properties up to \$55,000.00: 0.5% of the value of consideration.

Between \$55,000.01 and \$250,000.00: 1.0% of the value of consideration.

Between \$250,000.01 and \$400,000.00: 1.5% of the value of consideration.

Between \$400,000.01 and \$2,000,000.00: 2.0% of the value of consideration.

Over \$2,000,000.00: 2.5% of the value of consideration, where the land contains one or two single family residences.

“ City of Toronto Land Transfer Tax

If you are acquiring property in Toronto, an additional Toronto Municipal Land Transfer Tax (MLTT) is applied, in addition to the Ontario LTT. Essentially, you would pay both the Ontario LTT and the Toronto MLTT when acquiring a property located in Toronto.

The MLTT marginal rate structure is as follows:

For properties containing at least one, and not more than two, single family residences

For properties up to and including \$55,000.00: 0.5% of the value of consideration.

Between \$55,000.01 to \$250,000.00: 1.0% of the value of consideration.

Between properties \$250,000.01 to \$400,000.00: 1.5% of the value of consideration.

\$400,000.01 to \$2,000,000.00: 2.0% of the value of consideration.

Over \$2,000,000.00 and up to \$3,000,000.00: 2.5% of the value of consideration.

Over \$3,000,000.00 and up to \$4,000,000.00: 3.5% of the value of consideration.

Over \$4,000,000.00 and up to \$5,000,000.00: 4.5% of the value of consideration.

Over \$5,000,000.00 and up to \$10,000,000.00: 5.5% of the value of consideration.

Over \$10,000,000.00 and up to \$20,000,000.00: 6.5% of the value of consideration.

Over \$20,000,000.00: 7.5% of the value of consideration.

“ First Time Homebuyer Rebate

First time homebuyers (as defined by applicable legislation) in Ontario may be eligible for a rebate on the LTT of up to \$4,000.00. In Toronto, an additional rebate of up to \$4,475.00 on the MLTT is available for first time homebuyers.

LTT Calculation Example: For a property priced at \$600,000.00 in Ontario (outside Toronto):

0.5% on the first \$55,000.00 = **\$275.00**

1.0% on the next \$195,000.00 (\$250,000.00 - \$55,000.00) = **\$1,950.00**

1.5% on the next \$150,000.00 (\$400,000.00 - \$250,000.00) = **\$2,250.00**

2.0% on the next \$200,000.00 (\$600,000.00 - \$400,000.00) = **\$4,000.00**
Total LTT: \$8,475.00

If the same property is located in Toronto, you would double the total, paying both provincial LTT and MLTT.

**How Would a Court
Determine if a Pseudonym
Is Appropriate in a Sexual

Pseudonyms in an Open Justice System

Ontario's civil courts generally strive to provide an open justice system which limits the potentially detrimental effects of secrecy. There is a presumption that openness is preferable to adopting pseudonyms for participants or allowing complete publication bans.

If a survivor wants to use a pseudonym as a plaintiff in civil proceedings, courts have used a three part test to determine if such an exemption is justified. First, the plaintiff must establish the matter before the courts is serious. There is a low bar for this part of the test, and a sexual abuse or sexual assault case would almost certainly be considered a serious matter.

Second, the plaintiff must submit evidence from an independent third party that offers compelling support for the position that the plaintiff would likely suffer irreparable harm if named. For example, in the case of sexual assault survivors, the opinion of a treating physician or therapist may be





sought to explain the potential damage to the survivor's recovery or general mental health and well being. Lastly, the plaintiff must satisfy the court that, on the balance of conveniences, protecting their identity would be more favourable to the parties involved in the action and the public interest than openness.

In sexual abuse and sexual assault cases, the plaintiff would have an interest in protecting their privacy. A defendant may object to the pseudonym, as it could limit public scrutiny and / or the possibility that unknown / unidentified witnesses could learn of the action and offer evidence favourable to the defence. Although there is usually a public interest in openness in civil proceedings, permitting sexual assault victims to have anonymity has been shown to increase the likelihood that such assaults will come to light and that victims will be more willing to co operate with authorities.

Therefore, on balance, if a plaintiff has demonstrated they are likely to suffer irreparable harm by being named, the plaintiff's interest in privacy and the public interest in ensuring harmful acts are reported to authorities tend to outweigh defence objections.



Why Would a Survivor Want to Remain Anonymous?

Pseudonyms and publication bans are automatic in criminal court cases. Survivors may have particular concerns about attaching their name to publicly available court documents, including:

- A general desire for privacy and to avoid publicity which may re traumatize them
- Not wanting certain family members to know about the assault or abuse
- Having school age children who could be adversely affected

If a civil court declines to grant protection to survivors who petition for it, some of them will ultimately decide not to proceed with their lawsuit. However, it's important to know that it has become exceedingly rare for courts not to grant survivors a pseudonym request.

Watching Sports May Be Good for You but Beware ”

Although we may not realize the psychological benefits of attending a live sporting event, watching your favourite team in person can be good for you. In fact, according to CTV News, a 2023 study suggests going to a ball game may help increase life satisfaction.

Having tickets to a professional sporting event can be exciting but there are also risks involved, no matter how small. Thousands of people across North America suffer from some sort of injury at a game, although most are minor. However, serious injury and death has occurred.



You Assume Risk When Attending a Game

Over the years, sports organizations have taken steps to protect fans from harm. Teams will also post signs, discouraging distractions, such as cellphone use, while teams are playing. Of course, signs, higher glass and safety netting is not a 100 per cent guarantee of protection against flying pucks or baseballs. Accidents can still happen.

“The Assumption of Risk

When you purchase a ticket to a sporting event you agree to certain terms and conditions in exchange for the right to attend. Tickets typically include fine print that basically says you will not hold the organization liable for injuries or damage that may occur while you attend the event. It is not an unreasonable request if the event organizers have taken steps to ensure spectators are safe. You have a duty to protect yourself, which means not doing something reckless that could lead to harm or endanger you or someone else.

However, the assumption of risk does not excuse a sport's organization from liability if there was evidence that they did not exercise reasonable care in keeping the premises safe. If the safeguards meant to protect spectators are shoddy and someone is hurt, they may be entitled to seek compensation for their injuries.

Under Ontario's Occupiers' Liability Act, those controlling a property must do what is reasonable to ensure that all visitors are safe. The Act applies to any occupier of a property, including those who own sports stadiums. It is important to note that the legislation mandates that the duty of care is reasonableness but not perfection.

The standard of care is based on foreseeable risk. To make a successful personal injury claim, you must establish that your injury was caused by the occupier's failure to take reasonable care to ensure that conditions while the person was on the property, were satisfactory.

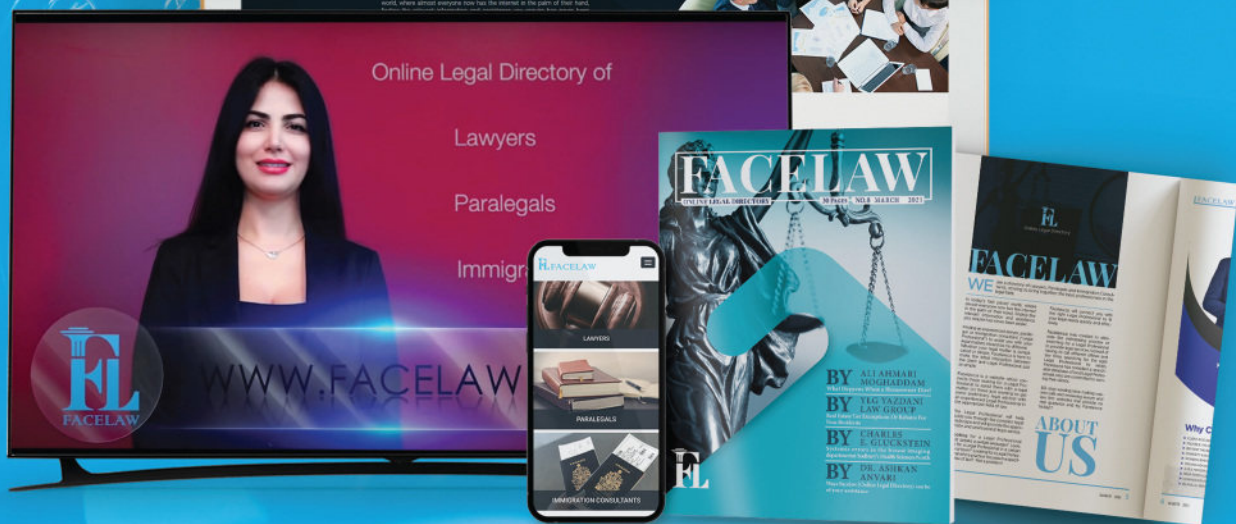
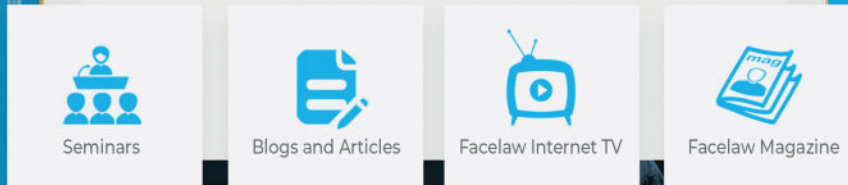
The law is complex and every case is different. An injury at a sporting event could result from the negligent or intentional conduct of another person or entity, unsafe property or defective products. That is why you should seek legal advice to determine your next step.

You typically have two years in Ontario to file a lawsuit for a personal injury claim so it is in your best interest to contact a Toronto personal injury lawyer early to ensure that proper steps are taken and that deadlines are not missed.

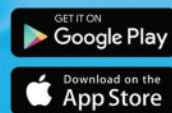

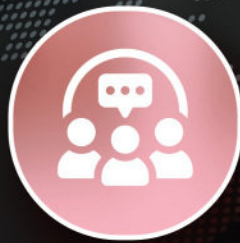

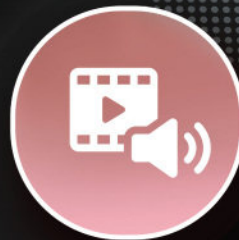

Understanding Theft Charges in Toronto and When You Need a Criminal Lawyer

In recent months, Toronto has seen a noticeable rise in theft related investigations in malls, supermarkets, and public areas. As a result, more individuals are being questioned, detained, or even charged for theft sometimes due to simple misunderstandings, mistaken identity, or technical errors in store security systems.

If you have been accused of theft, do not admit guilt before speaking with a criminal lawyer. Even a short apology or unclear statement can be interpreted as an admission and used against you later. You have the right to remain silent, the right to legal representation, and the right to understand the evidence being used in your case.

A criminal defence lawyer can help you by:

- Reviewing whether the accusation is supported by proper evidence
- Identifying errors in police procedure or store security reports
- Protecting your rights during questioning
- Negotiating withdrawal of charges when there is no intent or when a misunderstanding occurred

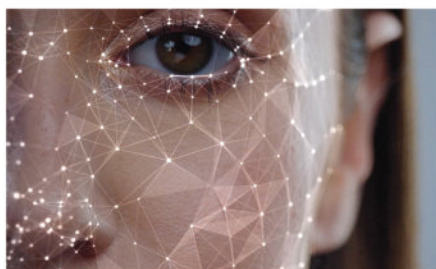

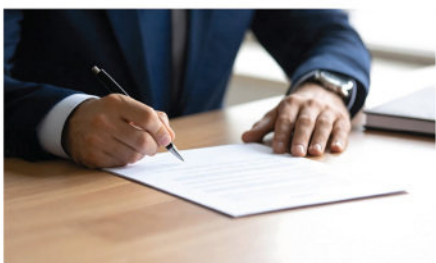
